Most committees (Anganwadi, VHNSC, VHSC, VMC, PDS monitoring committee) are not functional. Most people do not have any identity card and would like to get a ration card.

- 10. Based on the social audit findings, please list down **policy level suggestions** that you would like be incorporated in the implementation of schemes that were audited:
 - a) There are many people in the village who are living there for a long time but do not have voter IDs. A special camp should be organized so that people can get their Voter IDs in an easy manner.
 - b) There are many people in the village who are living there for a long time but do not have Ration Cards. A special camp should be organized so that people can get their Ration Cards in an easy manner. Since voter IDs are required for the ration card application, the Voter ID camp should be done first and then the ration card camp may be held.
 - c) Strengthen village level committees the committees should be constituted by the community in a public forum as per norms, the committee members should be given training (either in a class room or in the village by government field staff), field staff should participate in the committee meetings often and facilitate discussion and decisions.
 - d) ICDS centers are non-functional. Supervisors and CDPOs are not able to fix this. Maybe the anganwadi committee should be strengthened to monitor the centers and directly report to the district or state regarding issues at their centers. Good posters with clear entitlements should be prepared and pasted in public locations. Maybe entitlements for each child / woman can be given in packets rather than the practice followed currently where the anganwadi opens a bulk package and distributes a specific quantity (such as 763 gms of atta / week for every pregnant or nursing mother). Since the quantity is not easy to remember and people do not know this, it paves the way for pilfering.
 - e) Greater transparency is required in the implementation of the schemes. This could have prevented the scam in the implementation of the Nirmal Bharat Abhiyan scheme in the village. Field level functionaries should give information about all schemes and amounts sanctioned to committee members and not just to individuals in the village. Pro-active disclosures should be done for all schemes through wall paintings or posters.
 - f) PDS Everyone should get their entitlements at the price specified in the NFSA. If dealers are not given sufficient incentives, then this needs to be addressed so that they do not use this as an excuse to get extra money from the people.
 - g) Kerosene distribution details should also be entered in the ration card or a separate card should be given to the people.
 - h) Health Regular community outreach work needs to be done to regain the trust of the community. Today, most people are using the services in Assam but there are many problems associated with this birth certificate from Assam which people do not want, lack of accountability (if there are any serious problems tomorrow, Assam will just say it happend in Meghalaya and that it's not responsible), incorrect health data (for instance there were 8 home deliveries in this village from 2015 onwards but the VHN said these children were born in hospitals in Assam which is difficult to verify)
 - i) MGNREGS Key mandated processes and procedures are not being followed. This has led to fake entries as well as expensive material procurement. Awareness levels

- among community about their entitlements and the different types of works that can be taken is very low. Strict instructions should be given to follow processes. Participatory Planning to select appropriate works should be done in a systematic manner to ensure that useful assets especially relating to drinking water are built.
- j) Village level social audit committees need to be formed and provided training to carry forward the process.
- 11. Based on the pilot social audit, please list down the **changes** that you would like be made to the **social audit protocol** that was followed in the pilot and to the **formats** that were used:
 - a) Individual verification of all beneficiaries of all schemes will take too much time and is not feasible during the time allotted for the social audit. As far as possible, verification should be done in group meetings.
 - b) Information collection from certain departments need not be done ahead of time (the team can look at the registers in the village)
 - c) Workbooks have to be simpler not all formats in workbook should be filled. Depending on the circumstance, some forms can be skipped.
 - d) Village level Social Audit Committee may be formed during the public hearing
 - e) Public Hearing panel composition should have one senior District level representative, one CSO representative from neighbouring block, one Autonomous District Council and 2 other people
 - f) During the social audit process, the team should meet with each of the village level committees
 - g) During the social audit, selection of beneficiaries, planning for next year may also be done
 - h) Social Audit Unit should collect applications from people and give receipts during the social audit process itself; This should not be postponed till the public hearing day since there is usually a huge crowd and registering grievances is difficult at that time.
