The participants of the training include the Deputy Commissioners & District Programme Coordinator/ Project Directors & Additional District Programme Coordinator of the Concern Districts, Block Development Officer & Programme Officer, and Additional Programme Officer, Assistant Engineer / Junior Engineer as well as the representatives of the CSO/NGO.



To get acquainted with the Formats & Process of Social Audit under these two Schemes the trainees were provided with Copies of the FAQs, Social Audit Format (in English & Local Language), Note Pad & pens.

During the training there was an Interaction session where the following observations were taken as shown below:-

1. Clarification on payments for NGO if Social Audit process takes about 2 -3 days per VEC.
2. To get 100 % attendance of Job Card Holders during Door to Door verification is difficult as many of them are always busy in their fields.
3. Provision of different records needed for verification for both the Indira Awaas Yojana & Mahatma Gandhi NREGS .
4. Preparation of Entitlement Card for IAY Beneficiaries.

Conclusion:-

The training programme was concluded with an encouraging speech and a vote of thank from the Director, MSSAT. At the end of the training programme there was a distribution of the Social Audit Report Formats & FAQ (in English & Local Language) to different C & RD Block.
